A SPECIAL MEETING of the Council is hereby called to be held in
the Council Chamber, City Administration Building, Community
Concourse, San Diego, California, on Wednesday, February 7, 1973 at
the hour of 9:00 a.m.

Said meeting will be held for the purpose of the continuation of
the HEARING amending Chapter X, Article 1 of the San Diego Municipal
Code relative to On-Premise Sign Regulations for Commercial and Industrial
Zones; the proposed revisions include adding certain Sections to
Divisions 1 and 7; amending certain Sections in Division 4, and repealing
and amending certain Sections in Chapter IX, Article 5, Division 1; and
to consider new ordinances prepared at the direction of the City Council
amending the San Diego Municipal Code by adding a new Division 11 to
Chapter X, Article 1 relative to City-Wide On-Premise Sign Regulations
for Commercial and Industrial Zones; amending the CP, CR, CA, C-1, C, M-1D,
M-1, M-2A and M-2 Zones, the CO, CN, SR and M-IP Zones; and amending
Sections in Division 1, Article 5, Chapter IX, relating to signs.

Mayor Wilson called the Special Meeting to order at 9:30 a.m.

Ken Klein, Planning Department, and Chief Deputy City Attorney
Conrad answered questions directed by the Council.

Councilman Hitch entered the Chamber.

Dr. Claus appeared to speak regarding the Ordinances.

Councilman Morrow entered the Chamber.

Mayor Wilson recessed the Meeting at 10:30 a.m. Upon reconvening at 10:45 a.m., the roll call showed Councilmen O'Connor and Williams absent.

The Council resumed discussion of the Ordinances.

Mayor Wilson recessed the Meeting at 11:28 a.m. to reconvene at 2:30 p.m.

Upon reconvening at 2:49 p.m., the roll call showed Councilmen O'Connor, Williams, and Morrow absent.

Councilman Martinet entered the Chamber.

Joe Cannizzaro, Manuel Rotenberg, Hal Tebbetts, Philip Shafer, George Latham, Hamilton Marston, Donald Scholl, Roscoe Poland, Bob Augustine, Henry Coins, Marian Bear, and Gordon Wells appeared to speak in opposition to the Ordinances.

Harvey Goodfriend, former Mayor Frank Curran, and Andrea Lyon appeared to speak in favor of the Ordinances.

Councilman Bates left the Chamber.

Councilman Bates entered the Chamber.

On motion of Councilman Landt, said hearings were continued to Tuesday, February 20, 1973, Time Certain 2:00 p.m., for Planning Department to prepare a report relative to points raised in testimony given today.

In addition, the City Attorney was directed to amend Ordinance #2, regarding rooftop signs, to prohibit rooftop signs, except by CUP. This applies to rotating and flashing signs as well.

Also, the City Attorney was directed to amend Ordinance #2, Section 4, to make the Ordinance effective 30 days thereafter, and on page 48, under the title, "Existing Signs," to make the date 150 days for obtaining a permit.

There being no further business to come before the Council at this time, the Special Meeting was adjourned on motion of Councilman Johnson, at 5:20 p.m.
