A communication from the Purchasing Agent reporting on the sale of
obsolete and depreciated vehicles from the General Services Department; the
\$8,805 from the sale has been deposited with the City Treasurer in Central
Garage and Machine Shop Working Capital Fund No. 522, \$675 in the General Fund
No. 100, and \$25 in the Water Utility Operating Fund No. 500, was presented.

ORDINANCE NO. _____ 0.76-136

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE UPTOWN COMMUNITY PLAN AREA GENERALLY BOUNDED ON THE WEST BY BUCHANAN AVENUE, NEW JERSEY AVENUE, AND DELAWARE STREET, ON THE NORTH BY GOLDEN GATE DRIVE AND MISSION CLIFFS DRIVE, ON THE EAST BY PARK BOULEVARD AND GEORGIA STREET, AND ON THE SOUTH BY WASHINGTON STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 AND R-3 ZONES AS DEFINED BY SECTIONS 101.0409 AND 101.0411, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HERewith.

BE IT ORDAINED, by the Council of The City of San Diego
as follows:

Section 1. That property in the Uptown Community Plan Area generally bounded on the west by Buchanan Avenue, New Jersey Avenue, and Delaware Street, on the north by Golden Gate Drive and Mission Cliffs Drive, on the east by Park Boulevard and Georgia Street, and on the south by Washington Street, in the City of San Diego, California, within the boundary of the district designated "R-2" and "R-3" on Zone Map Drawing No. _____, filed in the office of the City Clerk as Document No. _____, be, and it is hereby incorporated into R-2 and R-3 Zones as such zones are described and defined by Sections 101.0409 and 101.0411, respectively of the San Diego Municipal Code.

Section 2. That Ordinance No. 12988, approved October 20, 1930 and Ordinances Nos. 3964 (New Series), 2428 (New Series) 6513 (New Series) and 10282 (New Series), adopted January 25, 1949, April 28, 1948, May 19, 1955, and April 25, 1970, respectively, be, and the same are hereby repealed insofar as they conflict herewith.

A motion by Councilman Morrow to refer to the City Attorney and City Manager for full report on the impact of the proposed Charter amendment, received no vote at this time.

Councilman Ellis seconded the previous motion by Councilman Hubbard to instruct City Attorney to prepare the proposed Charter amendment as proposed by the Police Officer's Association regarding binding arbitration, which was defeated by the following vote: Yeas-Councilman Hubbard. Nays-Councilmen Johnson, O'Connor, Williams, Morrow, Gade, Ellis and Mayor Wilson. Absent-Councilman Haro.

Councilman Williams' proposal to amend Section 12. The Council, was presented.

A motion by Councilman Morrow to file the proposed amendment, received no vote at this time.

Chief Deputy City Attorney Katz answered questions directed by the Council.

Discussion followed.

A vote was then taken on the previous motion by Councilman Morrow to file the proposed amendment, which passed by the following vote: Yeas-Councilmen Johnson, O'Connor, Hubbard, Williams, Morrow, Gade, Ellis and Mayor Wilson. Nays-None. Absent-Councilman Haro.

The City Manager's proposal to amend Section 129 by adding a provision authorizing the temporary suspension of an officer or an employee of the City against whom charges have been filed pending an investigation and a hearing on such charges, was presented.

City Manager McKinley and Chief Deputy City Attorney Katz answered questions directed by the Council.

Discussion followed.

A motion by Councilman Ellis to direct the City Attorney to bring back the language to amend as requested by the City Manager on Section 129, received no vote at this time.

City Manager McKinley answered questions directed by the Council.

A vote was then taken on the previous motion by Councilman Ellis, to direct the City Attorney to bring back the language to amend as requested by the City Manager on Section 129, which passed by the following vote: Yeas-Councilmen Johnson, O'Connor, Hubbard, Gade, Ellis and Mayor Wilson. Nays-Councilmen Williams and Morrow. Absent-Councilman Haro.

There being no further business to come before the Council at this time,
the Regular Meeting was adjourned on motion of Councilman Ellis at 5:32 p.m.
