NOTICED HEARINGS: Matters of: a - Proposal to adopt the revised Centre City Community Plan. The Plan encompasses approximately 1,200 acres and is bounded by Laurel Street and I-5 on the north, I-5 on the east, Commercial Street on the south, and San Diego Bay on the west. It represents an updated and revised comprehensive long-range development guideline for the central area of the City. The Paln responds to the recognition of the need for a unitifed effort to achieve previously established goals for Centre City, the City, the County, and the Port of San Diego. The new Plan is intended to provide a positive orientation to the waterfront and to emphasize an intensification of the central area development particularly government, office, commercial retail, hotels and residential. The Plan coordinates land use and transportation within the context of a qualitative urban environment which recognizes the need to conserve the human man-made and natural resources of the City; and b - Proposed amendment to the Progress Guide and General Plan for The City of San Diego - to amend the Map concerning that portion covered by the proposed revised Centre City Community Plan.
